## RULES & REGULATIONS

- Vendors (producers of the goods sold) may only sell items grown, created, or produced in Louisiana.
- Resale of items will not be allowed unless approved ahead of time.
- Taxing & licensing are determined by the State of Louisiana, the Parish of Terrebonne, and the City of Houma. The vendor is responsible for securing any tax ID or licenses required.
- Permitted items for sale may include vegetables, fruits, herbs, plants, honey, or seafood. Fresh or frozen meat products, cheese, eggs, artisan breads, & desserts are also permitted but must be produced by the vendor. Crafts & works of art are also permitted if created by the vendor.
- In order for the Downtown Houma Makers Market to ensure an appropriate product mix, vendors are permitted to only sell the items listed on their vendor application. If a vendor wishes to add a new item, they must inform the market coordinator beforehand.
- Each vendor will operate independently & set his/her own prices. Price wars or intentional undercutting will not be allowed. If selling fruits/vegetables by the pound, the vendor must use a scale certified by the Louisiana Department of Agriculture & Forestry with a current inspection sticker.
- Vendors are responsible for keeping their area clean & free of debris, trash, etc. during the market.
- All vendors must comply with the sanitary rules & regulations of the Parish & State Health Departments.
- Any conflict or potential conflict that may arise between vendors or between customers & vendors must be brought to the attention of the market coordinator for resolution.
- The market coordinator has the right to refuse any vendor
